





The Commonwealth Connection

Lynda Smith LM 2

When I first started researching my husband's SMITH family in 1977, my father in law gave me very few clues. He said that he had an auntie 'Rene' on his paternal side, an uncle Harry and another uncle Bernie. The one that initially intrigued me was Bernie/Bernard, as he had moved to South Africa at some stage. My father in law had a small Kodak box brownie style photo of Bernie and his family [photo at right], but other than that, he couldn't tell me much more, other than he had some connection to the SHAND surname and that he lived in Durban, Natal Province. As far as he knew, the remaining Smiths stayed in the UK other than his father, Frank, who had decided to settle in Australia after spending some years in the British Merchant Navy.

Bernard was born on Nov.11 1888 in Faversham Kent, to Alfred Henry SMITH and Frances Ann MARK. I eventually discovered that he was the sixth of seven children of this couple. Alfred came from a family of seafarers, such as Thames River bargemen, merchant seaman and shipbuilders/owners. Back in the 1990s there was little available via the Internet, on South African BDM records, so I hired a researcher. The first document I received was Bernard's 1968 Death Notice- which is a handwritten transcription on a basic form. This was quite informative. I found that Bernie had married Eunice Maud nee DAVIES in Durban SA and that they had one son, Frank Mark who was over 21 when his father died. The notice also confirmed Bernie's date and place of birth and his parent's full names. The marriage date was not given.

Eunice was still living in 1968, so I tried for her death details via the same researcher. This document stated that Eunice had actually died in Canada [Cranbrook, British Columbia] in May 1972, but was registered in SA for probate reasons. Why was Eunice there? Unfortunately,



the document did not give her parent's names or her date of birth. Place of birth was Porthcall [various spellings] in Wales. Luckily, Canadian BDM indexes were available online and I was able to obtain a copy of that DC. This document gave me Eunice's date of birth and parent's first names. Surprisingly, she had only been in Canada for 21 days. The informant was her son, Frank Smith, of 1207 South 10th Street, Cranbrook.

I then started to search shipping records to try and find out when Bernard and Eunice moved to South Africa. At that stage, I had no idea when they married, or if their son Frank was born in SA or the UK. I located Bernard in the 1891 and 1901 UK Census records, but could not

definitely find him in 1911. There is a possible entry for a Bernard Smith, boarder with Henry BAYLEY and his family in Southampton. Bernard was listed as a yacht shipwright, which fits with his family ancestry. The DAVIES name in Wales is like SMITH and I have not had any success so far identifying this family.

In 2002 I wrote a letter to the editor of a Canadian newspaper, "The Daily Townsman" in Cranbrook, trying to locate Vera and Frank. I actually received some replies! A former neighbour of Frank and Vera SMITH gave me their son Mark's contact details. I wrote to him and he gave me his mother's details. She had recently re-married and her new surname was SCHETTERER. Vera was very helpful. She gave me lots of information on her family. She was able to tell me that her first husband Frank Mark SMITH was born on March 16, 1926 in South Africa.

Frank did an apprenticeship in shipbuilding, then spent a number of years travelling the world, working for various shipping lines. He decided to spend some time in Vancouver, and it was here that he met Vera in 1952. Vera then travelled to South Africa and they married there in Feb. 1953. Their son Mark was born in Durban in Nov. 1953. The family decided to return to Calgary Canada in 1958, where Vera had grown up. Their daughter Janis was born there in 1960.


I also checked Merchant Navy records, to see if Bernard had followed his older brother's career choice. The UK National Archives have a card for Bernard, including a photo of him. The photo, [on righ]t, my father in law had verified that this was the same man. He was recorded as having voyages from 1918-1921 as a carpenter. Using Findmypast.com I have so far located numerous sea voyages, initially for Bernard, and then Bernard and Eunice and finally Eunice and their son. In 1931 Bernard left Durban for the UK, listed as a master shipwright. In 1933 Eunice and son Frank travelled to the UK to stay in Tottenham. Bernie's sister Elsie lived there. After each UK visit they returned to Durban. Vera verified that Bernie bought the "James SHAND Ship Repairs" business and ran it until 1957, so my father in law was correct again.

Bernie travelled to the UK alone in 1947. In

1949, his son Frank was travelling as a tourist, back to the UK. His occupation was listed as shipwright. He also called in to Quebec on his way home to Durban.



Perhaps this is when his interest in Canada began. In 1956, Eunice accompanied Bernie to the UK, for a stay in Kent. Two of Bernie's other sisters lived in that county. By 1960, Bernard was listed as 'retired' when he and Eunice travelled to the UK, then to Canada and finally



back to Durban. I assumed from this and Eunice's DC, that they were visiting their son Frank in Canada.

In 2015, I checked Familysearch.org for South African records. I was amazed to find Bernard and Eunice's marriage details freely available. They married in Durban on 21 June 1924 at the Musgrave Rd Congregational Church.

I researched the Church and sadly discovered that it was demolished in 1967, to make way for a freeway. Not too far away in the same records, I found Frank's marriage to Vera WILLIAMS.

Frank Mark SMITH died in 1996, in Canada. His son Mark Lee SMITH married Heather [maiden name unknown at this time] and they had three children. Mark is an electrician and I believe he still lives in Canada. Frank's daughter Janis has been married twice and has two sons. She was living in Washington, USA in 2003. I haven't heard from this line for nearly fifteen years, so I will have to do some re-connecting!

As an aside, the Uncle Harry mentioned at the beginning, also spent time in Africa. Harry was born in 1897 and he enlisted in the RAF at the beginning of 1918. He was an apprentice fitter and turner. He was discharged in 1919 and married Lilian/Lillian Adeline TWIST in 1924 in Kent. He became an engineer and he spent many years working in exotic Commonwealth locations such as Lagos [Nigeria], Zanzibar [Tanzania] and Takoradi [Ghana]. Lilian was with him for these adventures and I have found a number of sea voyages for them. They did not have any children. Their last voyage in 1952 stated that Harry intended to stay in the UK. I believe Lilian may have died in 1965, but I have not yet verified this. As you can imagine, a

death date for Harry is also proving illusive.

It seems that this humble family from Kent included at least three intrepid travellers of the British Empire. Auntie Rene did also exist, but that is anot


Centenary Ringing

Hobart is the home to a wide variety of memorials, far too many to name here.

When we visited Hobart last year, we spent some time in the grounds of The

Anglesea Barracks. Unfortunately, we just did not have enough time to visit to Queen's Domain Park, the home of the Cenotaph and Boer War memorial amongst other memorials.

The Anglesea Barracks occupies an area of 6 hectares, being only one kilometre from the centre of the city. They are the oldest Australian Army barracks still in operational use, celebrating its bicentenary in December 2011.

On the 2nd December 1811, the visiting NSW Governor, Lachlan Macquarie rode to the top of a small hill south-west of the town and declared that it was the spot for a barracks. The hill has been called Barrack Hill from that day. Macquarie directed that barracks were to be built to house 150 men, with quarters for the officers and a hospital to accommodate 32 sick persons. Construction began on the first buildings to occupy the site in 1814.

The barracks were named Anglesea by Governor George Arthur (Governor from 1823 – 1837) after the Marquis of Anglesey, who was Master General of the Ordnance in England during Arthur's tenure. Anglesea Barracks remained the headquarters of the British Imperial Forces in Tasmania until the last British regiment stationed there left in 1870.

Apart from being a working Army Unit, it houses offices of the RAAF and the Navy as well as a wonderful Military Museum manned by very knowledgeable volunteers. Within the Museum are several very realistic lifesized diaramas depicting various stages in the building's history. We did not venture up the stairs, however I did see a realistic looking model of a soldier in Vietnam.

This picture [right] shows the proximity of the Barracks to the heart of Hobart.

Within the grounds of the Barracks are many memorials to those who served and their Units. Included in the long list of structures is the impressive 99th Regiment Memorial.



This monument is unique as it was the first war memorial to be erected in Australia and also the only such memorial to be erected by a British Regiment serving in Australia.

The 99th Regiment of Foot was stationed in Hobart from 1848 to 1856. The monument commemorates twenty four men of the Regiment who were killed on active service in the New Zealand Maori Wars of 1845-46 and was erected, in 1850, from money raised by voluntary subscription from officers and men.

The Peacekeeper

Dedicated in May 2011. This memorial commemorates those who have lost their lives on peacekeeping and peacemaking operations, and also recognises the contribution and commitment of military, police and civilians who are serving overseas.

The memorial is a timber sculpture featuring a soldier rescuing a child. It was created by Vietnam veteran Bernie Tarr of Geeveston.

Anyone interested in such things, the Barracks is home to a comprehensive collection of ordnance. ... *





Nineteenth Century Journalism at its Best and Worst

One of my maternal ancestral lines is the

MARNEY/MAINEY/MERNEY/ MAHONEY family from Tasmania. The spelling variations of this name have caused some issues in the past, but I bravely tried TROVE again recently and found some gems. Sadly, this family suffered more than its fair share of grief. A number of children died young and some of the daughters lost their husbands to an assortment of accidents and illnesses. Others reached adulthood, but did not marry. Both John MARNEY and his wife Sarah WILSON were convicts. John was a shoemaker before his conviction and later returned to this trade. Sarah became a very well-known and much loved midwife. Together they had twelve children.

I had known for some time that Daniel MARNEY, born 28 November 1827, died as a child, but I didn't know the details. I found three different views of what must have been a terrible event. I doubt the parents appreciated the judgemental and flippant tones of the journalists of the day.

Tasmanian Weekly Dispatch (Hobart Town, Tas.: 1839 - 1841), Friday 20 March 1840, page 7*The Turf*.

NEW TOWN RACES. The weather on Tuesday was most unfavourable, rain and wind throughout the day. In despite of all, however, there were about three thousand persons on the course, the great attraction being the running between Van Tramp and Gulnare. There was an unusual display of booths, and no pains appeared to have been spared to make the accommodation for the public, complete. Fortunately, it was so, the rain, during the whole of the day, being so heavy, as to drive everyone to cover, except during the time of running; of course, very few ladies were present, and this, with the absence of the gav equipages which were in attendance, the second and third days deprived the first day of its principal pleasures. During the afternoon, a fatal accident occurred to a son of Mr. Marney's, who was thrown from a horse, and killed on the spot.

Colonial Times (Hobart, Tas.: 1828 - 1857), Tuesday 24 March 1840, page 6

The Races. The races, with all their amusing excitement have once more passed away, leaving on the minds of the winning sportsmen, a very pleasureable [sic] impression. We are not of those who decry and censure harmless recreations; and conducted as were the recent races, everything passed off with the greatest order and regularity. True it is that one fatal accident occurred, and which was just as likely to happen in the streets of Hobart Town, or on the high road, as on the Race-course. We allude to the decease of a young lad named Marney, who imprudently mounted a strange horse, which threw and kicked him to death. Leave we, however, this melancholy topic, and all others, and come at once to the Races.

Hobart Town Courier and Van Diemen's Land Gazette (Tas.: 1839 - 1840), Friday 20 March 1840, page 2

Fatal Accident.—An inquest was held at Mr. Cooley's, the " Horse and Jockey," New-town road, on Thursday, the 19th March, on the body of a youth named Daniel Marney, the son of Mr. Marney, the shoemaker, in Brisbane-street. It appeared in evidence, that Mr. Lord's overseer gave the boy the horse to mind. The lad mounted the animal, and was riding about, when the horse suddenly shying threw him off, and his feet becoming entangled in the stirrup leathers, he was dragged a considerable distance, and at some speed, before the animal could be stopped. When this was at last effected, the poor boy was found to be a mutilated mass of bruises, and the countenance so shockingly

mangled, that it was difficult to identify him. The jury returned a verdict of "accidentally killed."

Thankfully, at least the report from the Inquest presented some facts on poor Daniel's death. None of the reports say whether or not Daniel's father was present at the time. Some twelve years earlier, another child, William, born September 27 1824, featured in the paper.

Tasmanian (Hobart Town, Tas.: 1827 - 1839), Friday 19 December 1828, page 3

Accident by Fire.—An Inquest was held by J. Spode, Esq., our worthy Police Magistrate and Coroner, on Wednesday, on the body of a child of John Marney, a Javelin man, whose death was occasioned by its having in the absence of its parent got too near the fire, whereby the flame communicated with its shirt and death was the consequence. We lament that the press of British Intelligence prevents our this week giving insertion to the whole proceedings, upon the Inquest, which we are most desirous of publishing. well knowing how extremely careless many otherwise affectionate parents are, as respects their children getting near fires.

Marney's poor infant lost its life without a shadow of blame attaching to either of its parents, except that of leaving it alone in a room where there was a fire, which it could approach. We trust this will be a warning to parents to prevent the possibility of their children experiencing similar calamities.

By the way, **a javelin man** is an archaic name for a guard, often used in courts or as protectors of judges as

they travelled to and from assizes. In the later middle ages, such men carried pikes or halberds. In 1827 there was a report that Hobart's javelin men were now to be called constables.

The MARNEY family included six boys and six girls. Two adult sons worked in the whaling industry and were presumed lost at sea. One son died at six months of age, from water on the brain, and their last remaining son died of tuberculosis at the age of twenty five. [This child born in 1841 was given the same first name as his deceased brother.]

Mercury (Hobart, Tas. : 1860 - 1954), Monday 26 March 1866, page 1

DEATHS

MARNEY. -On 24th March, at his residence, Brisbane-street, Daniel (Frederick), the only surviving son of the late Mr. John Marney, aged 25. The funeral will move from his late residence on Tuesday, the 27th instant, at half-past 2 p.m. No circulars.

It is believed that this line of the MARNEY surname did not survive as a result of all these sad male deaths. There are others in Tasmania with the same surname, but as yet I have found no connection to this family. A daughter died at four days old in 1826, and another unmarried daughter died at forty one from a stroke in 1874. Only the remaining four daughters managed to marry and produce children. My ancestor was the last child of the family, Julia Ann, who married Alfred Thomas SMALLHORN in 1862. They had seventeen children, but only twelve made it to adulthood.

One of Julia's sisters, Catherine, born 1830, married three times, having been widowed twice. Her first marriage was in 1851 and her husband William WATERS died two years later of lung disease, leaving her with a young son.

In 1855, she married again, only to lose this husband that same year. People's Advocate or True Friend of Tasmania (Launceston, Tas.: 1855 - 1856), Monday 16 July 1855, page 3

LAMENTABLE BOAT ACCIDENT. — On Wednesday afternoon, between five and six o'clock, as a young man named Marshall Collier, son-in-law of Mr. John Marney, of Brisbane-street, was proceeding to Risdon from Hobart Town in a lime boat called the Providence, having his wife and child on board he met with a watery grave. When off Pavilloin[sic] Point, the Providence put about, when one of the sails str[u]ck him, and he fell into the water. Every exertion was made by those on board to render him assistance; and, although he was a good swimmer, it is supposed that the heavy clothes which he had on at the time of the accident occurred. carried him down before any assistance could be rendered him. The unfortunate wife (Catherine) saw her husband disappear before her eyes, without her having the power to render him the slightest assistance. The body has not yet been recovered, although several of his friends are using their best endeavours with the grappling-irons.

Catherine later gave birth to her second child, Mary Catherine COLLIER in October 1855. Mary sadly died from whooping cough in January 1856. On July 15, 1856, Catherine married a widower, Edward Henry IVEY, whose first wife, Sarah LYONS/LINES had died on 31 July 1855 of lung disease. They had had a number of sons and a daughter. Edward Henry IVEY and Catherine went on to have four more children: Charles John 1857, Robert

David 1860, who died of tuberculosis at the age of twenty, Sarah Jane 1863 and Julia Kate 1866 who died of consumption on Boxing Day 1866. Edward was a baker and sometime auctioneer. Thankfully, both Edward and Catherine both lived until the 1880s and experienced the joy of becoming grandparents.

Another sister, Mary, born 1822, married Michael WATERS at the age of sixteen. Michael was thirty and was a whaler. They had at least seven children before Michael was admitted to the New Norfolk Lunatic Asylum. According to his death certificate, Michael died of apoplexy/unsound mind in 1854. The death notice paints a different picture. It appears that Mary did not remarry. I cannot yet prove whether William WATERS and Michael WATERS were related.

Hobarton Guardian, or, True Friend of Tasmania (Hobart, Tas. : 1847 - 1854), Saturday 20 May 1854, page 3 DIED.

At his residence, Brisbane-street, Hobart Town, Mr. Michael WATERS, age 44 years, leaving a widow and seven children to deplore his loss. Friends are respectfully invited to attend his remains to the Cathedral of St. Joseph's Church, at half-past 2 o'clock on Monday next. Mercury (Hobart, Tas.: 1860 - 1954), Thursday 18 April 1867, page 1

WATERS.—On the 17th instant, at her late residence, All Nations Hotel, Hobart Town, after a long and painful illness, Mary, relict of the late Mr. Michael Waters, aged 44 years, deeply regretted by a large circle of friends. The funeral will move from her late residence, on Saturday next, at half-past 2 o'clock,

when friends are respectfully invited to attend.

I don't know who cared for Mary's children after her death, but I feel it is safe to assume that her remaining sisters would have played a part.

John MARNEY evidently ran a successful shoemaking business for many years. He gained a number of pieces of land within Hobart and rented out some houses, mostly in Brisbane St.

A Crime as Old as Time.

Lynda Smith LM2

I came across this court report while searching for articles on my MARNEY family in Tasmania. I felt very sorry for Miss Jane STAFFORD. I have tried searching Tasmanian birth records for 1836-37 but have not found a child born to Jane.

Colonial Times (Hobart, Tas.: 1828 - 1857), Tuesday 15 March 1836, page 7

Hobart Town Police Report. Tuesday, March, 8.

Jane Stafford, a very decent looking female, begged the Magistrate's attention to her tale of woe. She stated that she had arrived in the Colony about two years since as servant to Messrs. King and Armstrong, missionaries, and remained in their service about eight months, and was then recommended to Mr. Sherwin, of Liverpool-street, as a servant; she lived with him as such for about four months, and then took private lodgings, where Mr. Sherwin visited her, and promised her marriage; and as she believed him to be a single man, permitted him to continue his visits, fully expecting he would marry her; that he continued his visits for some months, that during that period both of them had gone astray, and discovering her shame to him, and finding he had a wife in the Colony, he had deserted her; that she was in the family way by him, and stood in want of assistance, and was in a bad state of health; that on the previous Saturday night, she had been to his house and spoke to him, and he

threatened her with a constable; that on this occasion she was sitting on a chair in his shop, and without giving him any provocation, he took her up and dragged her about his shop, violently pushed her against the door, and hurt her much. Mr. Sherwin, who appeared to labour inwardly, declared his innocence and was much affected at the charge, and endeavoured to explain matters. Jane was sworn to her complaint, and further stated, that Mr. Sherwin, before he pushed her out, had told her to go and said she should not come there, and took her round the waist to push her out; that she got stronger with resentment and passion, and pushed again, but that Mr. Sherwin got the best of her. Mr. Sherwin looked at Jane, and said, "can you say, I did it? look at me; .oh! you false, wicked woman! Why, your worship, I have had no more to do with the woman than yourself. I can bless God for his goodness to me in giving me fortitude to withstand such temptations, besides, I am a married man, and I have a missionary at the door to speak in my behalf." That gentleman knowing nothing of the party's transactions, his attendance was unnecessary. The woman, having refused to leave the defendant's premises, defendant justified the assault and the case was dismissed.

REMINDER - State Records is out of the way and there are no shop facilities. It will be necessary to bring your lunch. There is a lunchroom available with a microwave oven, refrigerator and tea/coffee making equipment. Lockers are also available for bags etc. **PLEASE NOTE......IF THIS IS YOUR FIRST VISIT**

A reader's ticket is necessary and free, and can be organised online at www.records.nsw.gov.au; It will be waiting for you when you arrive.

If you wish to speak to staff at State Records prior to this trip the phone number is 02 9673 1788.

Bags are not allowed in the reading room, but you can take in a folder with research tasks etc. You are only allowed to use pencils in the research room. If you require paper records such as wills, insolvency records, school records etc it is a good idea to pre-order these documents so they will be available when you arrive, saving you some waiting time. Up to four (4) items can be pre-ordered. You will find the reference numbers and the two (2) pre-order forms on the website. Remember any item that has a REEL NUMBER does not have to be ordered as reels are stored along the wall and are easily accessed.

There are various ways of obtaining copies of your information: Using the microfilm reader/printers for photocopies – you will need \$1 and \$2 coins to use these machines (\$1 for A4 and \$2 for A3). Bring a supply of coins. You can download copies from the digital copiers for microfilm for free, using your own memory stick. You are also welcome to bring a digital camera to photograph original records. State records also have a digital camera that you can use for photographing original documents in the reading room, and again images are downloaded to your memory stick. The staff will photocopy any paper documents at a cost of 45 cents per A4 page and will endeavour to have them ready for when you leave.

The bus will leave State Records no later than 4:00 pm.
